## TEMPORARY MEMBERSHIP

Temporary membership cards may be issued to Prospective Members upon full payment of dues. The temporary card must be in the Prospective Member's possession at all times on club property. Card must be returned upon acceptance or denial of club membership. The temporary membership card is a one-time issue to any one Prospective Member.

### Allows Prospective Member

1. Access to SWCC property at his/her own risk. SWCC is not responsible for injury or damages.
2. Access to campground and its privileges (full members have priority on electrical hookups).
3. To fish from bank or piers only. Must sign in with name and temporary membership number (no personal boats or club boats may be used)
4. Access to club sponsored events
5. To bring spouse and their children under 21 years of age (no guest) to the club
6. To work off following year's dues

### Does Not Allow Prospective Member

1. Access to firearms range at any time
2. To attend any Members' Only events (Generals Meetings included)
3. To bring any guests to club property other than spouse or their children under 21 years of age for any reason.

The temporary membership is designed to allow prospective members to be introduced to club members not familiar with said person. During the temporary period, the rights on the temporary membership card can be revoked for any VALID (board approved) reason and dues forfeited. Prospective members will go through the 1st reading and 2nd reading as required by the By-Laws before receiving full membership. The temporary membership card is valid from the date of payment of dues and initiation fees, until the date of the General Meeting in which the application will be read for the 2nd time. The sponsoring party's signature and a board member's signature must be on the card to validate. All dues are valid until December 31st of the year of application.
